

# HECA Reporting 2019

## Introduction

The Home Energy Conservation Act 1995 ('HECA') requires all 326 local authorities ('LA's) in England to submit reports to the Secretary of State demonstrating what energy conservation measures they have adopted to improve the energy efficiency of residential accommodation within that LA's area. This covers measures to improve properties in the owner-occupier, private rented sector, and social rented sector. BEIS uses data submitted through LAs HECA returns to inform policy thinking on energy efficiency, and to build an ongoing picture of local and national energy efficiency policy delivery.

These guidance notes are issued in accordance with the Secretary of State's powers under section 4 of the Act and are to alert LAs of amendments to the HECA reporting framework in advance of May 2019 when the next reports are due. In previous years, reporting rates have been disappointing, with 282 reports submitted in March 2015 out of 326 LAs, and only 151 in March 2017. The refreshed reporting system for 2019 streamlines the process and reduces LA reporting burdens. Newly structured around a series of questions and direct information points, the amended framework aims to support LAs to provide information and updates on the key energy efficiency topics of interest to BEIS Ministers. It will also enable LAs to provide a consistent picture of energy efficiency promotion and delivery across England within a standardized framework. Following the principles of open data, the department may publish the information in an open data format to allow wider access and interpretation of the data, while ensuring that such publication complies with the terms of GDPR.

## HECA 2019 Reporting Requirements

The Report is to be divided by sections to capture information on a range of key themes:

### Headline & Overview

- What main strategy and schemes LAs currently have to promote carbon reduction and/or energy efficiency, stakeholders involved and impact at a societal and economic level.

### Communication

- How LA engage stakeholders (including consumers and businesses) to promote awareness of energy efficiency.

### Green Local Supply Chain

- How LAs engage local businesses involved in the promotion of energy savings products and the societal benefits alongside any local economic impact this might have.

### Private Rental Sector Minimum Energy Efficiency Standards

- How LAs enforce and promote awareness of the PRS Minimum Energy Efficiency Standards that came into force in April 2018.

### Financial Support for Energy Efficiency

- Financial programmes used by LAs to promote energy efficiency.

### Fuel Poverty

- How LAs identify those in fuel poverty and any initiatives used to address this.

### The Energy Company Obligation (ECO)

- How LAs are using the recently introduced ECO 'flexible eligibility' programme to refer certain households in fuel poverty or with occupants on low incomes, who are vulnerable to the effects of cold homes, to ECO obligated suppliers for support.

### Smart Metering

- How LAs promote awareness and uptake of smart metering.

All questions are optional, but responses highly encouraged. While reporting is focused on energy savings related to homes, you are welcome to provide additional information on energy efficiency improvements in non-domestic properties, but this is fully optional. There will be a final free response section permitting local authorities to discuss any additional activities which they feel are relevant.

## Submission of HECA 2019 Reports

For the 2019 reporting year, the Department for Business, Energy and Industrial Strategy (BEIS) is piloting the submission of reports via a digital platform, and for this year LAs will be asked to populate their HECA Report and submit materials via a SurveyMonkey submission. No other reporting material or submissions will be required. LAs continue to be required to publish their responses, and they can do this in whichever form they wish, so long as the published report contains relevant information submitted via the digital platform. It is not necessary for LAs to publish all the information submitted via the digital platform. Before the online survey is completed, the chief executive or director of the LA should approve the submitted content. If this approach proves effective and supports the engagement and compliance of a greater number of authorities than in recent previous years, BEIS will consider how this approach can be further improved for the 2021 reporting year.

<p><i>Free text response to question 4a - please outline in no more than 200 words</i></p> <p>The London Borough of Hounslow (hereafter referred to as 'the Council') has delivered a wide range of domestic energy saving and carbon reduction schemes.</p> <p>The Council's priority for owner occupied and privately rented properties has been to target support to low income and vulnerable residents and those with long-term health conditions. Since 2013/14, the Council's 'Better Homes, Better Health' scheme has provided practical advice through home visits to 3,176 households (April 2013 to June 2019). Since April 2017, the scheme has undertaken 671 home visits across the Borough – and this is being further supported through 'Homes4Health', a collaboration which brought together 4 local authorities, 1 housing association, charities and a range of local partners to connect the most vulnerable people to a wide range of resources. Further details are set out in section 24.</p> <p>The Council owns and manages 16,500 homes (including leasehold properties) and aims to ensure these are safe, warm and energy efficient. Since April 2017, the Council has delivered measures including upgrading 1,095 domestic heating and hot water boilers to A-rated standard,</p>		

district heating upgrades (replacing end of life boilers with new high efficiency condensing boilers) and replacing landlord lighting across several sheltered schemes with LED lighting systems. We have also done pilot external wall insulation (EWI) installations in preparation for future larger scale programmes.

On 18/06/19 a motion put forward by Councillor Dunne (Cabinet Member for Communities and Workforce) at a meeting of Borough Council was carried, declaring a climate emergency which requires urgent action. The Council is committed to reviewing the existing arrangements in place to reduce the Council's carbon footprint and will identify measures towards a goal of making the Council's activities carbon neutral and ultimately zero-carbon within the shortest achievable timeframe.

The consultation on the Council's draft Housing Strategy 2019/24 ended on 01/08/19). The draft strategy includes proposals for delivering new homes and providing excellent housing services for our residents over the next four years. The Council's vision is underpinned by five objectives, one of which is 'To create a cleaner, safer and greener living environment'. Amongst other proposals, this would see the Council commit to completing all building and upgrade programmes to the highest standards of thermal efficiency.

For all tenures of domestic properties, there will be a continuation of the Council's 'Better Homes, Better Health' scheme which provides a free package of support to help eligible residents improve their homes, keep warm and save money on energy bills.

Planned investment across the managed social housing stock that will improve energy saving/carbon reduction includes:

- replacing old inefficient gas boilers and faulty radiators as well as upgrading heating controls;
- upgrading district heating systems and water risers / infrastructure in blocks to improve the efficiency of heating systems;
- window upgrades targeting single glazed and end of life double glazed units;
- insulation of any remaining loft or roof voids;
- external wall insulation improvements to circa 250 properties on the Worton and Worple Estates (Isleworth), Holly House (Hounslow) and other properties;
- modernising or upgrading the lifts across our blocks.

It is not possible to provide a cost for this work, which spans several different Council Teams and schemes involving capital and revenue expenditure across a wide set of initiatives that go beyond domestic energy saving and carbon reduction.

The Council works with a wide range of partners across housing and energy saving / carbon reduction projects. Our work on domestic energy efficiency and carbon reduction includes partnerships with Groundwork London (registered charity and partner delivering 'Better Homes, Better Health') and outreach work with a wide range of community and voluntary organisations.

Last year, the Council's 'Better Homes, Better Health' scheme delivered 610 home visits and achieved a total of £95,640 in financial savings for Hounslow residents by switching to cheaper energy tariffs and applying for grants and discounts and therefore reducing cost of bills and cost of living. The financial savings also includes energy efficiency measures and behavioural change actions that enabled residents to use their energy more efficiently. The scheme has in addition achieved carbon savings of 38,384.7 (kg CO<sub>2</sub>e) and 7,233,847 litres of water saved through installation of energy saving measures and behavioural change action pledges. 187 Hounslow residents were also referred to vital onwards services such as 'One You Hounslow' for health check services and to Housing Services for repairs and home improvements, to improve health and well-being of residents.

It is not possible to reliably measure improvement in energy efficiency or societal impacts of energy efficient improvements across the social housing stock. Theoretical savings from energy efficiency measures are possible – but the Council does not have access to energy consumption data and full household attribute data from properties. Once developed, the Council's social housing Asset Management Strategy will set targets for practical measurement of investment outcomes in respect of Council's social housing stock, for example as measured through SAP ratings, etc.

8 What lessons have you learned from delivering this scheme(s)?

The success of the Council's 'Better Homes, Better Health' scheme is largely attributable to the collaborative work of the Council's Housing, Public Health and Social Services Departments with charities, public and third sector organisations. This has enabled the scheme to have a cross-borough and multi-tenure reach while maintaining local connections enabling resources to improve health and wellbeing through warm and healthy housing and reducing energy costs for vulnerable households. The pooling of resources through the partnership – notably the 'Homes4Health' scheme - has avoided the duplication that can occur when different organisations are funded to deliver similar advice services through different funding routes. This scheme has showcased the strength in local agencies working together on fuel poverty, particularly in London which has had a disproportionately low share of the Energy Company Obligation (ECO), the primary source of Government funding for fuel poverty.

The Council's broad approach is to use all legal and informal powers at our disposal to set an example for private landlords, use our powers of persuasion and negotiation to bring about improvements in standards, and where this fails to step in to enforce robustly against inadequate stock maintenance and poor management in the private sector. This includes supporting enforcement of the Energy Efficiency (Private Rented Property) (England and Wales) Regulations 2015 and enabling landlords to access support and funding where relevant to improve the standard and energy efficiency of properties. The Council will use EPC information as part of range of information to prioritise higher risk properties.

Through the 'Better Homes, Better Health' scheme, the Council works with a registered charity and various community groups to identify residents/properties in fuel poverty and provides them with a package of support which aims to help improve their homes, keep warm and save money on energy bills. The service combines the local authority ability to issue Energy Company Obligation (ECO) Flexible Eligibility declarations (which has been delegated to another Local Authority) with the charity and community sector's capacity to connect with vulnerable residents. Data is used to identify areas where qualifying residents and properties are more likely to be found and, through a range of outreach activity, vulnerable residents are supported through the process of applying for fully funded works.

Tackling fuel poverty is inextricably linked to the Council's wider objectives to reduce carbon emissions in Hounslow. For example, we are incorporating energy and debt advice into our front-line offer. Our 'Better Homes, Better Health' scheme provides a free package of support to help eligible Hounslow residents improve their homes, keep warm and save money on energy bills. Also, by embracing the need to undertake energy efficient / carbon reduction retrofits across the social housing stock, constructing high performing new builds, and utilising legal powers and negotiation on private landlords (amongst others), the Council seeks to continuously tackle fuel poverty and deliver affordable warmth - providing warm, comfortable and affordable homes.

The Council would like to see Government continue to review their suite of policies that together seek to tackle fuel poverty, keep fuel bills affordable and reduce carbon emissions. This will ensure that, as policies continue to evolve, they are designed to work more effectively together towards the shared objectives of meeting fuel poverty obligations, meeting statutory climate change targets, and keeping household bills affordable across the wider population.

The Council's 'Better Homes, Better Health' scheme targets vulnerable households offering a package of support designed to tackle fuel poverty and winter ill health in a holistic way. In 2018/19, this scheme joined the 'Homes4Health' project which is the regional initiative and collaboration where 4 local authorities (London Borough of Hounslow, Royal Borough of Kensington & Chelsea, London Borough of Hammersmith & Fulham, London Borough of Camden), 1 housing association (Octavia Housing), Groundwork London (Registered Charity), and a range of local partners working together to target and support fuel poor homes, and connect the most vulnerable people to a wide range of resources – whilst also broadening partnerships and increasing impact in the target areas. 'Homes4Health' aims to meet Fuel Poverty Strategy England's objectives of increasing comfort, reducing bills and improving health outcomes for households experiencing severe fuel poverty which will be achieved primarily through an effectively targeted comprehensive home-visit service for 7,830 fuel poor households, in the most deprived areas, across the 4 local authority areas in London (multi-year project).

Locally, the Council also utilises the holistic approach of our Financial Inclusion Team to support residents in fuel poverty. This Team offer direct advice on money management and financial health, and have procured a more specialist debt advice to help those whose situation threatens their housing security and health.

**The Energy Company Obligation**

The Energy Company Obligation (ECO) is an obligation on energy suppliers aimed at helping households cut their energy bills and reduce carbon emissions by installing energy saving measures. Following the Spring 2018 consultation, the Government set out in its [response](#) that ECO3 will fully focus on Affordable Warmth – low income, vulnerable and fuel poor households. The recently introduced ECO “[flexible eligibility](#)” (ECO Flex) programme allows LAs to make declarations determining that certain households in fuel poverty or with occupants on low incomes and vulnerable to the effects of cold homes, are referred to ECO obligated suppliers for support under the Affordable Warmth element of ECO. LAs involved are required to issue a Statement of Intent that they are going to identify households as eligible, and the criteria they are going to use; and a declaration that the LA has been consulted on the installation of measures in a home.
