For premises occupied by a non-profit-making organisation we can give rate relief of up to 100% of the National Non-Domestic Rate bill. Clubs or organisations will need to show why they deserve this relief. We will judge your application on its merits, taking account of the contribution your organisation makes to the borough. The categories of non-profit-making organisations which can apply for discretionary rate relief are set by law. They are as follows.

- Institutions or other organisations whose main objectives are philanthropic (that is, charitable and for the benefit of others), religious or concerned with promoting people's welfare, science, literature or the fine arts.
- Clubs, societies or other organisations occupying premises for the purpose of recreation.

When we are deciding who to give discretionary relief to, we consider the following.

- Whether all sections of the community can join the organisation (for example, whether fees are set at a reasonable level).
- Does the organisation actively encourage people from particular groups (for example, young people, women, people with disabilities, ethnic minorities and so on) to become members?
- Are the organisation's facilities available to people other than members?
- Is the organisation a self-help group that is not receiving a grant?
- Does the organisation encourage new activities in the area?
- Does the organisation provide training or education to its members?
- Does the organisation provide facilities that are not available from us?
- Is the organisation associated with a national organisation?

A copy of your constitution and your latest annual report and accounts would normally answer these questions for us, but we welcome any extra information which is relevant. Please use the lined sheets at the end of the application pack if you cannot answer any questions in the space provided or if you want to provide supporting evidence.

Relief will be granted for one year at a time. Notice of entitlement will show the start and end date of the relief.


